#### **CIRCULAR**

Sub: Online application for extension of registration of projects.

Extension of registration of real estate projects is mandated under Section 6 of the Real Estate (Regulation and development) Act, 2016 read with Rule 7(1) of the Goa Real Estate (Regulation and Development) (Registration of Real Estate Projects, Registration of Real Estate agents, Rates of Interest and Disclosures on Website) Rules, 2017 and Regulations thereof.

- Goa RERA would like to bring to the notice of all real estate promoters/builders and other stake holders with regard to online application for extension of registration of real estate project.
- In order to facilitate to apply online for extension of registration of real estate projects, the promoters/builders are directed to submit extension application online.
- 4. They may follow the given below process:
  - a) Use Promoters login under the tab extended projects registration.
  - b) Fill/select the details, Project date of extension, Reason for extension, upload the document-Form 'V' -Application for Extension of Project.
  - c) Upload the Renewal of Construction License.

- d) Upload the Renewal of Development permission/ Technical clearance order.
- e) Upload the Quarterly building details, Development details.
- f) Upload the Annual Statement of Accounts/ Annual Report (Form-6).
- g) Upload any other documents, if any.
- h) Fill the payment details and attach the payment receipt. (Amount of fee same as registration fee)
- i) Click on declaration and submit the form.
- 5. All real estate promoters/builders and stake holders are hereby directed to apply **online** for extension of real estate projects henceforth. This circular comes into force with immediate effect.
- 6. This issues with approval of the Goa RERA.
