ORDER

The Government vide its Notification No. 1/RERA/Chairman & Members/2018/2200 dated 16th October 2019 has appointed Chairperson and Members to the Goa Real Estate Regulatory Authority under Section 20 of the Real Estate (Regulation and Development) Act, 2016.

In accordance with the provisions of Section 71 of the above Act adjudicating compensation under Section 12, 14, 18 and 19, the Authority shall appoint in consultation with the appropriate Government one or more judicial officers as deemed necessary who is or has been a District Judge to be as Adjudicating Officer.

In exercise of powers conferred under Section 71 of RERA Act, 2016, the Authority in consultation with the Government appoints the following retired District Judges as Adjudicating Officers on its panel:-

- (i) Shri. Ashley Leonard Camillo Noronha.
- (ii) Shri. Deoram Narayan Argade.

Both the above panel of Adjudicating Officers will be entitled remuneration @ Rs. 20,000/- per case decided. In case the matter is settled amicably, the adjudicating officer will be entitled for Rs. 15,000/- per case. The adjudicating officer will be paid conveyance allowances for attending work as per approved rates of Goa Tourism Development Corporation.

Further, the appointment will be initially for a period of two years extendable up to 65 years of age.

The Adjudicating matters will be assigned to the panel of adjudicating officers by the Authority.
