## <u>ORDER</u>

(Delivered on this 23<sup>rd</sup> day of the month of January 2025)

This is a complaint filed for refund of amount of ₹10,00,000 (Rupees Ten Lakhs only) along with interest under the Real Estate (Regulation and Development) Act, 2016.

2. The respondent was duly served and Ld. Advocate Shri Gauravvardhan

Nadkarni for the respondent submitted that the matter is likely to be settled.

3. Ld. Advocate Gauravvardhan Nadkarni for the respondent has thereafter

placed on record a Memo dated 08.01.2025 along with a ledger entry indicating

encashment of the cheque by the complainants in settlement/refund of all the

money paid by them to the respondent at exhibit 192/c and submitted that the

subject matter of ₹ 10,00,000/- was paid to the complainants vide cheque dated

17.12.2024. An email notice was issued to the complainants for their say returnable

on 23.01.2025, since they were absent. The complainants thereafter forwarded an

email dated 10.01.2025 at exhibit 198/c stating the matter has been amicably

settled between the parties and that the complainants have received the full

settlement amount as acknowledged by the ledger entry placed on record by the

respondent and therefore, no further claims or grievances have remained

unresolved and hence, the case may be considered as disposed of.

4. In view of the Memo placed on record by respondent at exhibit 192/c and

the email of the complainants dated 10.01.2025 at exhibit 198/c, I have no

difficulty to dispose of the matter as duly settled by the parties.
