Sub: Implementation of Section 12A of weapons of Mass Destruction and their Delivery Systems (Prohibition of Unlawful Activities) Act, 2005: Designated List (Amendments)- reg.

The Security Council committee has enacted amendments in Para 12 of the Guidelines for Reporting Entities (Real Estate Agents) under the Prevention of Money Laundering Act, 2002 dated 04/05/2023 (The Guidelines), issued by D G Audit (The Regulator under PMLA).- reg vide DGA/Tech/REF/1/2023-TECH-O/oDG-DGA-HQ-DELHI, dated 21/08/2023. The same has been uploaded for information and viewing by the real estate agents, buyers and sellers of properties.

2. The information is being issued in pursuance of instructions from Ministry of Home Affairs, Government of India' order F No. 14014/01/2019/CFT, dated 02/02/2021 regarding Procedure for implementation of Section 51 A of the

unlawful Activities (Prevention) Act 1967, and instruction contained in Government of India, Ministry of Finance, Department of Revenue's order F No. P-12011/14/2022-ES Cell-DOR, dated 30/01/2023 regarding the Procedure for Implementation of Section 12A of weapons of Mass Destruction and their Delivery Systems (Prohibition of Unlawful Activities) Act, 2005.

- 3. The real estate agents who are the reporting entities under the PMLA are advised to refrain from entering into any transactions with persons whose identity matches with the persons detailed in the aforesaid lists/notification and to immediately report to the Regulator and the Director, FIU-IND, in case they come across any such person. They are also advised to perform enhanced due diligence in respect of a client whose name matches with any of the matches so listed.
