**Sub: Security Council Al- Shabaab Sanctions Committee Adds Three Entries to Its Sanction list- reg.**



With reference to Guidelines for reporting entities (Real Estate Agents) under Prevention of Money Laundering Act, 2002 dated 29.11.2023, issued by DG Audit (The Regulator under PMLA), Security Council Al-Shabaab Sanctions Committee has added Three Entries to Its Sanction list- reg, vide DGA/Tech/REF/1/2023-TECH-O/o DG-DGA-HQ-DELHI, dated 22.05. 2024. 2. The real estate agents who are the reporting entities under the PMLA are advised to refrain from entering into any transactions with persons whose identity matches with the persons detailed in the aforesaid lists/notification

and to immediately report to the Regulator and the Director, FIU-IND, in case they come across any such person. They are also advised to perform enhanced due diligence in respect of a client whose name matches with any of the matches so listed.

They may also be advised to perform enhanced due diligence in respect of a client whose name matches with any of the persons so listed.
