With reference to Guidelines for reporting entities (Real Estate Agents) under Prevention of Money Laundering Act, 2002 dated 29-11-2023, issued by DG Audit (The Regulator under PMLA), Security Council 1718 Sanctions Committee Amended One Entry on its Sanctions List vide DGA/Tech/REF/1/2023-TECH-O/oDG-DGA-HQ-DELHI, dated 18-09-2024. They are also advised to perform

enhanced due diligence in respect of a client whose name matches with any of the matches so listed.
