With reference to Guidelines for reporting entities (Real Estate Agents) under Prevention of Money Laundering Act, 2002 dated 29-11-2023, issued by DG Audit (The Regulator under PMLA), the Security Council ISIL (Da'esh) and Al-Qaida Sanctions Committee removes One Entry from its Sanction List, vide Letter dated 24/02/2025. They are also advised to perform

enhanced due diligence in respect of a client whose name matches with any of the matches so listed.
