That I shall get accounts audited within six months after end of every financial year by practicing chartered accountant and shall produce a statement of accounts duly certified and signed by such practicing chartered accountant and it shall be verified during audit that amount collected for a particular project have been utilized for the project and withdrawal has been in compliance with proportion to percentage of completion of the project.
- 7. That I shall take all the pending approvals on time, from the competent authorities.



- 8. That I shall inform the authority regarding all the changes that have occurred in the information furnished under section (2) of section 4 of the act and under rule 3 of the said rules, within seven days of the said changes occurring.
