2.Furthermore, we have verified the Canara Bank current accounts No.120002788314 from 1st April 2023 to 31st March 2024 to confirm the amounts withdrawn from the designated account. However, we are unable to certify whether the amounts received daily from the allottees have been specifically utilized for the project.
