OCCUPANCY CERTIFICATE.

Occupancy Certificate is hereby granted to you for the construction of residential/commercial building, approved vide Construction Licence No VP/N/Const.L.46/2019-20 dated 21/02/2020 in Survey No.101/1-F, at Nagmodem, of Village Navelim Taluka Salcete, Goa, in pursuance of Resolution No. 3(2) duly approved by the Village Panchayat Navelim in its meeting held on dated 16/01/2023, and based on the Completion Order issued by the Dy. Town Planner vide letter No.TPM/31681/Nav/101/1F/2023/46 dated 01/01/2023 and as per the NOC for issue of Occupancy Certificate issued by the Health Officer vide letter No. PHC-Navelim/DHS/Occupancy/2022-23/1156 dated 10/01/2023.

Subject to the following conditions:-

- 1.All conditions stipulated in the completion Order /Technical Cleareance Order from PDA/TCP should be strictly adhered to.
- 2. This Certificate shall be treated as NOC for obtaining Water & Electricity(Single/Three Phase) Connection.
- 3. The Waste collection, Segregation & Compositing Station alongwith Sanitary waste incinator needs to be functional on daily basis. Dry waste to be disposed through proper channel as per the guidelines from Goa Solid Waste Management Corporation.
- 4. Not to discharge the waste water into the existing Drainage / Nullah / Pond in the open ground which is unhygienic in the vicinity.
- 5. If you fail to comply the above observations, this Panchayat will revok the said occupancy issued to you.
