TECHNICAL CLEARANCE ORDER

Technical Clearance is hereby granted for carrying out the proposed construction of commercial and residential building by Mr. Gauribhushan Shivdas Karpe as per the enclosed approved plans in the property zoned as Commercial Zone (ZP) in Regional Plan for Goa-2021, situated at Village Cacora Taluka Quepem Goa, bearing Survey no. 11/16 with the following conditions:-

- 1. Construction shall be strictly as per the approved plans. No changes shall be effected in the approved plans/approved built spaces without the prior permission of this Authority.
- 2. The permission granted shall be revoked, if any information, plans, calculations, documents and any other accompaniments of the application are found incorrect or wrong at any stage after the grant of the permission and the applicant will not be entitled for any compensation.
 - 3. The development permission will not entitle the applicant for making/laying any claim on water and any other connection from the Government of Goa.
- 4. The Developer/applicant should display a sign board of minimum size 1.00mts. x 0.50mts. with writing in black colour on a white background at the site, as required under the Regulations.
- 5. The applicant shall obtain Conversion Sanad under the Goa Land Revenue Code, 1968, before the commencement of any development/construction as per the permission granted by this order
- 6. The septic tank, soak pit should not be located within a distance of 15.00meters from any other existing well in the plot area/plan.
- The commencement and the completion of the work shall be notified to the authority in writing in appropriate. forms.
- 8. Completion Certificate has to be obtained from this Authority before applying for Occupancy Certificate from the licensing authority as per the internal modification approved by this office.
- 9. Storm water drain should be constructed along the boundary of the effected plot abutting to the road.
- 10. Adequate Utility space for the dustbin, transformer etc. should be reserved within the plot area.
- 11. In case of any cutting of sloppy land of filling of low lying land, are involved, prior permission of the Chief Town Planner shall be obtained before the commencement of the works per the provisions of Section 17(A) of the Goa Town and Country Planning Act, 1974.
- 12. In case of compound walls, the gates shall open inwards only and traditional access, if any passing through the property shall not be blocked.
- 13. The ownership of the property shall be verified by the licensing body before the issuing of the licence.
- 14. The Municipality/Panchayat shall ensure about the availability of required portable water and power supply before issue of license.
- 15. The adequate arrangement for collection and disposal of solid waste generated within the plot shall arrange to satisfaction of Village Panchayat.
- 16. Adequate storm water network shall be developed up to the satisfaction of Municipality/Village Panchayat and same to be connected to the existing drain in the locality.
- 17. The Municipality/Village Panchayat shall take cognizance of any issue in case of any complains/Court orders before issue of construction licence.

- 18. Open car parking spaces shall be developed and effectively utilised for parking purpose.
- 19. The applicant shall dispose the construction debris at his/her own level and the same shall be taken to the designated site as per the disposal plan given by the applicant in the Affidavit to be produced to the Municipality Village Panchayat.
- 20. Required numbers of trees shall be planted by the applicant in the said plot/property as per the Regulation 18 of the Goa Land Development and Building Construction Regulations, 2010 regarding landscaping of open spaces/trees plantain along the roads and in develop plots.
- 21. This Technical Clearance Order is issued on the basis of Order dtd. 28/3/2018 and 1/6/2022 as per Regional Plan for Goa 2021.
- 22. Payment of prescribed cess of 1% of the total cost of construction project as a prerequisite for obtaining Completion Order.
- 23. In case the proposal involves felling of trees, the Project Proponent/owner shall obtain prior permission from Tree Officer/ Forest Department as mandated under Section 8 & 9 of Goa Preservation of Tree Act.

- cc) An Engineer who designs the RCC structure, of the project proponent is liable for structural designs and stability of the project, structural liability certificate issued by an Engineer Vinayak G. Shet Verenkar having Reg.no. SE/0008/2020.
- dd) This Order is issued with reference to the applications dtd.20/11/2023 from Shri Gauribhushan shivdas Karpe.
- ee) This Technical Clearance Order is issued based on the approval of the Government vide no.TPQ/CT/7809/0 Cacora/11/16/2023/2987 dtd. 30/11/2023.
- Applicant had paid Infrastructure Tax of Rs. 17,49,774/- (Rupees seventeen lakhs forty nine thousand seven hundred seventy four only) vide challan no. 85 dtd. 28/12/2023.

THIS ORDER IS VALID FOR THREE YEARS FROM THE DATE OF ISSUE OF CONSTRUCTION LICENCE, PROVIDED THE CONSTRUCTION LICENCE IS ISSUED WITHIN THE PERIOD OF THREE YEARS.
