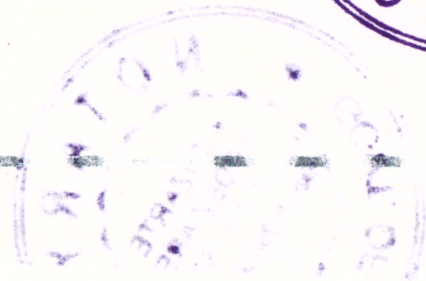

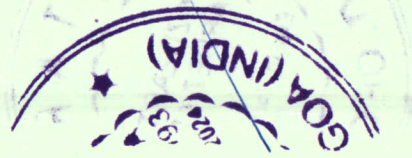
AFFIDAVIT CUM DECLARATION






I, Mr. Atmaram V. Fulari, Director of M/S Classic Square Realty Pvt Ltd, promoter of project named "SUMMER SQUARE", son of Vinayak Fulari, aged 45 years, Indian National, promoter of the proposed project, do hereby solemnly declare, undertake and state a sunder:

1. That we have a legal title report to the land bearing Survey No. 255/2 situated at Anjuna Bardez Goa, on which the development of the proposed project is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.
2. That the project land is free from all encumbrances.
3. That the time period within which the project shall be completed by us from the date of registration of project is 31/03/2027.
4. That the project shall be completed through self-financing as mentioned in online form and no advertisement /marketing/sale/booking/ offer for sale etc as per the provision of the section 3(1) of RERA ACT 2016 shall be carried out prior to RERA registration.

7. That we shall get the accounts audited within six months after the end of every financial year by a practicing Chartered accountant and shall produce a statement of accounts duly certified and signed by such practicing Chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
8. That we shall take all the pending approvals on time, from the competent authorities.



9. That we shall inform the authority regarding all the changes that have occurred in the information furnished under sub section (2) of section 4 of the Act and under rule 3 of the said Rules, within seven days of the said changes occurring.
10. That we have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
11. That we shall not discriminate against any allottee at the time of allotment of any apartments the case may be.

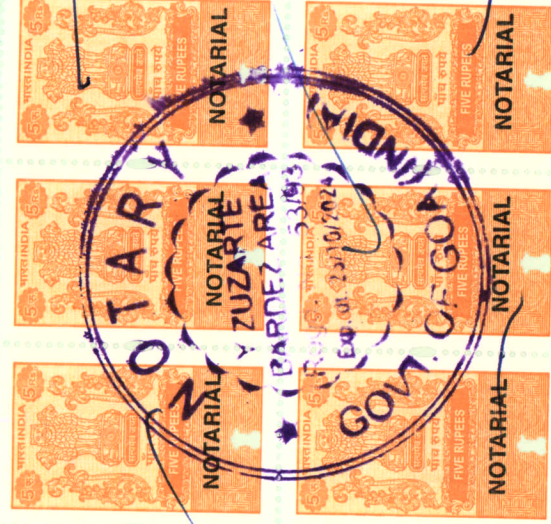
