1. This Certificate is issued in accordance with the provisions of the Real Estate (Regulation and Development) Act, 2016 read along with The Goa Real Estate (Regulation and Development) (Registration of Real Estate Projects, Registration of Real Estate Agents, Rate of Interests and Disclosure on Website) Rules 2017.
2. We have obtained all necessary information and explanation from the Promoter, during the course of our audit, which in our opinion are necessary for the purpose of this certificate.
3. We hereby confirm that we have examined the prescribed registers, books and documents, and the relevant records of “**Gajraj Builders and Developers**” for the period ended **01.04.2024 to 31.03.2025** and hereby certify that-
 - i. The Promoter has/have completed **80%** of the project titled “**Julieta Complex**” bearing Goa RERA Reg. No. **PRGO07211380** located at **Near Kerkar Hospital, Aquem, Margao, Salcete, Goa, Salcete, South Goa.**
 - ii. Amount collected during the year in question for this project for the financial Year 2024-25, In Specified designated A/c Rs. 2,04,21,375/- and amount collected till date (Up to **31.03.2025**) is Rs. 7,30,05,881/-.
 - iii. Amount withdrawn during the year for (Year)**2024-25** is, from Specified designated A/c Rs. 2,21,09,839/-, and amount withdrawn till date (From start of the project up to **31.03.2025**) is Rs. 6,79,66,817/-
4. We certify that “**Gajraj Builders and Developers**” has utilized the amounts collected for “**Julieta Complex**” project only for that project and the withdrawal from the designated

bank account of the said project has been in accordance with the proportion to the percentage of the completion of project.

Exceptions

1. The certificate has been drawn on the basis of total amount of money received from allottees of **Julieta Complex** since the inception of the project until 31st March 2025 and amount expended since inception of the project until 31st March 2025.
2. It is not possible for us to certify whether the amount received on daily basis from the allottees has been utilized for the project. Hence the method followed is the total amount of money received during F.Y 2024-25 from the allottees of the project and the total amounts deposited in the RERA designated account and the total withdrawals made from the RERA designated account during the F.Y 2024-25
3. Further the said certificate has been issued on the basis of limited review of the books of accounts and not on the basis of any site visit done as we are not technically qualified to perceive the progress of work on site for which we rely on the Architect certificate dated 22nd July 2025 for completion of work on site.

Restriction on Use

This certificate has been issued at the specific request of the said company and as per the statutory requirement of third proviso to sub section 2 of Section 4 clause (1) of Real Estate (Regulation and Development) Act, 2016 read with corresponding rules and regulations framed therein required submitted before Goa RERA Authorities is not to be used for any other purpose or to be distributed to any other party
