Subject to the following conditions:-

- All conditions stipulated in the completion Order/Technical Clearance Order from PDA/TCP should be strictly adhered to.
- a. The use of the residential building should be strictly as per the approval.
- b. All parking spaces/stilt floors should be used for parking of vehicles only and should not be converted for any other use.
- c. No attachment/alteration to the building shall be carried out and the building shall not be occupied unless the approval of authority.
- d. The Applicant should make independent provision for Garbage disposal within the Plot Area in vermin composition station as shown on approved plan and dispose the same properly in scientific manner.
- 2. This certificate shall be treated as NOC for obtaining Water and Electricity connection.
