COMPLETION ORDER

Completion is hereby certified for **proposed construction of residential Villa (11 nos)** which is constructed as per the Technical Clearance granted by this Department vide Order no. **TPB/7313/PAL/TCP-2022/906 dt. 25/02/2022** at Sy. No. 6/3 of village **Paliem** Taluka **Bardez** subject to the following conditions.

1. The use of the residential **Villa** should be strictly as per the approval.
2. All parking spaces/Garage should be used for parking of vehicles only and should not be converted for any other use.
3. No attachment/alteration to the **Villa** shall be carried out and the **Villa** shall not be occupied unless the occupancy certificate is obtained from the concerned Village Panchayat on presentation of this order.
4. As regards complaints, pertaining to encroachment, Judicial Order/directive and other legal issues, the same may be verified and confirmed by the concern village Panchayat before issuing Occupancy Certificate.

NOTE:-

- a) This Completion Order is issued based on the structural stability Certificate issued by project **Engineer Paresh Gaitonde** dtd. **16/08/2025** TCP Reg. No. **ER/0057/2010**.
- b) This Completion Order is issued based on the completion certificate issued by **Engineer Paresh Gaitonde** dtd. **16/08/2025** TCP Reg. No. **ER/0057/2010**.
- c) The Completion Order issued is from the planning point of view only. As regards to the structural stability and safety of all, concerned owner and his Engineer shall be solely responsible and the Town Planner and his all officials are indemnified and kept indemnified forever against any civil and criminal liabilities and for any kind of liability, whatsoever in the event of any untoward incident or structural failure/collapse. This will hold good (and will be valid) even in case some of any prescribed documents inadvertently are not on record (not received by the Town & Country Planning office or wrongly submitted by Applicant / Applicants representative.
- d) The applicant shall pay Labour cess of 1% of the total cost of construction project to the Commissioner of Labour & Employment and Secretary Goa Building & Other construction Workers Welfare Board before applying for completion certificate to the Authority.
- e) NOC from Directorate of Health Services is required to be obtained regarding availability of Automated External defibrillator (AED) before issue of Occupancy Certificate by local Authorities.
