3. We estimate Total Estimated Cost of completion of the building(s) of the aforesaid project under reference as Rs.1,50,00,000/- (Total of Table A and B). The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate/completion certificate for the building(s) from the Dy.
