OCCUPANCY CERTIFICATE

1. All the conditions stipulated in the Completion Order/Technical Clearance Order from PDA/TCP should be strictly adhered to.
2. This Certificate shall be treated as NOC for obtaining Water and Electricity Connection.
3. The Applicant should make independent provision for Garbage disposal within the plot area by constructing Compost Pit and dispose the same properly in scientific manner.
4. Not to discharge the waste water into the existing Drainage/Nullah/Pond in the open ground which is unhygienic in the vicinity.
5. If you fail to comply the above observations, this Panchayat will revoke the said occupancy issued to you.
