



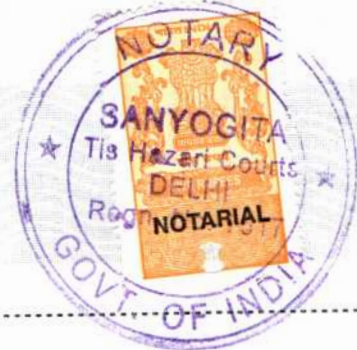

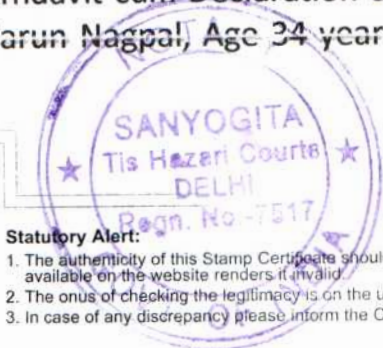

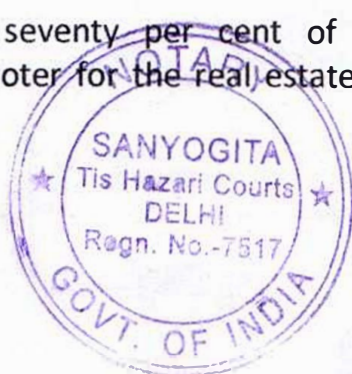

5.
