



Gude, Advocate for (B-i), (B-ii), (C-i) and (C-ii) before the panel members of Permanent Lok Adalat on 09/10/2004.

The interested parties amicably resolved the dispute over the partition of the inheritance left behind by the deceased Shri Gopala Vishram Porobo Nachinolcar on
