3. We estimate Total Estimated Cost of completion of the building(s) of the aforesaid project under reference as Rs.9,48,23,000 (Total of Table A and B). 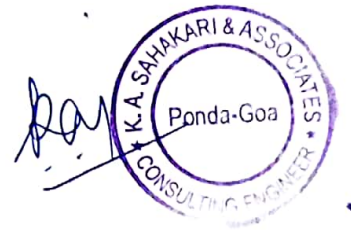

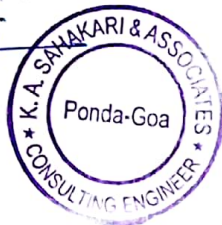
