That in pursuance of such intention and in consideration of natural love and affection which the Donors have for the said Donees out of their own free will, without fraud, coercion, or under influence from any body whatsoever and in full possession of their mental faculties, they the Donors do hereby gift, convey, grant, transfer and confirm unto the said Donees the ownership, right, and possession in the said property bearing survey no.171/10 situated at Assagac, Village Panchayat of Assagac, Taluka and Sub District of Bardez, District of Goa and more particularly described in the schedule hereunder written.
2. And that the said Donees shall and may from time to time and at all times hereinafter peacefully and quietly enter upon, have, hold, occupy, possess, and enjoy the property hereby gifted and receive the rents, issues, and profits therefrom and every part thereof without any let or hindrance whatsoever from or by said Donors or by any person or persons claiming from or through them.
3. That the Donees herein do hereby accept the said gift with thanks and gratitude.
4. That the value of the Gift is Rs.44,000/- which corresponds to the market value of the property hereby gifted.


