4. We certify that “**LATITUDE HOMES AND AMT VENTURES PRIVATE LIMITED**” has collected amount for **CASA TRANQUIL** project have withdrawal from the designated bank account of the said project has been in accordance with the proportion to the percentage of completion of the project.

Further the said certificate has been issued on the basis of limited review of the books of accounts and not on the basis of any site visit done as we are not technically qualified to perceive the progress of work on site for which we rely on the Architect certificate dated 31<sup>ST</sup> March 2025 for completion of work on site.
