Definitions:-

Section 4(2)(I)(D) of the Act provides that the funds from the RERA Account must be "Utilized" only to cover the construction cost and the cost of acquiring land for that project. This provision states that the funds from the RERA Account shall be "Withdrawn" by the promoter after it is certified by an architect, an engineer and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.

That is to say promoter can withdraw only profit portion.

Amount Collected – Means the Total Money collected (net of booking cancellation) towards the sale of units in the project.

<u>Amount Withdrawn</u>- Means withdrawal by promoter for other than the project purpose.

And
