### Subject: Information Regarding Exemption from Acquiring Conversion Sanad

Dear Sir/Madam,

I am writing to inform you about Government Order No. RD/LND/273/76-77 dated 19.02.1977, issued by the Revenue Department, Government of Goa. In accordance with this order, lands acquired or purchased by the Goa Housing Board are exempted from the provisions of Sections 30, 32, 33, and 34 of the Goa, Daman and Diu Land Revenue Code, 1968. This exemption has been granted under the powers conferred by Section 35 of the said Code.

The order was published in the Official Gazette, Series II, No. 49, dated 04.03.1977. To facilitate your review, copies of the order and notification have been attached to this communication.

The working of the said society is not satisfactory in as much as the annual general body meeting for the year 1974-75 was not convened by the society as required in terms of Section 75(1) of the Maharashtra Co-op. Societies Act, 1960. As the society did not comply with the provisions of the aforesaid section, this office vide order No. RSR-AGM-GEN-AR(P)/74-75 dated 5-5-1976 directed the E.O. (Coop/V.P.). Bardez to convene and finalise the annual general body meeting of the society for the year 1974-75. The E.O. (Coop/V.P.) vide his notice No. CDB/Coop/AGM/76/229 dated 17-5-1976 convened the annual general body meeting of the society on 6-6-1976 and subsequently forwarded the proceedings to this office. Vide resolution No. 6 passed in the annual general body meeting, the general body resolved that all the members who attended the said meeting were defaulters and as such they were disqualified to be elected on the Managing Committee and have requested to appoint an Administrator to manage the affairs of the society. manage the affairs of the society.

In the circumstances, a notice under Section 78(1) of the Maharashtra Co-op. Societies Act, 1960 as applied to the Union Territory of Goa, Daman and Diu read with Rule 61(2) of the Co-op. Societies Rules, 1962 was issued to all the Managing Committee members of the aforesaid society requesting them to show cause as to why the Managing Committee should not be superseded. A reply from Shri Shriram Naik Salgaonkar, and 4 other members of the society has been received at Sr. No. 2 above requesting this office not to appoint an Administrator. However the reply is not convincing and cannot be accepted and as such in view of the above I remove the Managing Committee of the said society and pass the following order:—

The Maem Vainguinim V.K.S.S. (Vikas) Society Ltd., Maem-Bicholim was registered on 8-5-1963 under registration No. RES-(c)-35/Goa with the main object of meeting the agricultural credit requirements as well as other agricultural requisites in cash as well as in kind in its area of operation.

But on a review of the working position of the said society it is observed that the same has not been found to be up to satisfaction as far as its loaning activities, management, recovery position and the general financial conditions are concerned thus defeating the very purpose for which it has been registered. On account of the unsatisfactory working position of the society, its gradually deteriorating financial condition and the general apathy displayed by the members towards its working, this office had to appoint an Administrator to manage the day to day affairs of the society. Even after the appointment of the Administrator no large change in the working of the society has been noticed. In view of this it is felt that no useful purpose will be served by continuing the affairs of the society and therefore, it has been found expedient to wind up its affairs in pursuance of which I pass the following order.

#### Order

In virtue of the powers vested in me under Sub-Section (1) of Section 102 and Sub Clause (ii) of Clause (c) of Sub Section (i) of Section 102 of the Maharashtra Coop. Societies Act, 1960 as applied to the Union Territory of Goa, Daman and Diu, read with Rule \$4 of the Coop. Societies Rules, 1962 and in view of the fact that no useful purpose will be served by continuance of the aforessid society and on my own motion, I, S. V. Bhadri, Asst. Registrar of Coop. Dr. Wilfred D'Souza had filed this petition challenging the Bye-Election to the 23-Benaulim Assembly Constituency held on the 9th June, 1974. The counting of the valid tendered votes ordered by me in pursuance of the election petition was carried out as per the orders of this Court.

2. In accordance with the order of today's date, the procedure laid down by Section 102 of the Representation of

Peoples' Act was followed as after the scrutiny and the counting of the tendered votes and the initial east votes, there was an equality of votes. Both, the petitioner and the respondent have polled 4651 votes. The tile was therefore resolved by lot. The drawing of the lot was in favour of the petitioner, Dr. Wilfred D'Souza. In view of the provisions of Section 102 of the said Act, one vote shall be added to the votes polled by Dr. Wilfred D'Souza. Consequently, Dr. Wilfred D'Souza gets 4652 votes and the respondent gets. 4651 votes. I, therefore declare the petitioner as elected to the Legislative Assembly of the Union Territory of Goa, Daman and Diu in the Election held on the 9th June, 1974 for the 23-Benaulim Assembly Constituency in place of the respondent, Francisco Menino J. Ferrao. The petitioner shall be admitted as a member of the Legislative Assembly of Goa, Daman and Diu and the respondent shall cease to be a member of the Assembly.

3. The Election Petition is disposed of accordingly.

4. The Registrar shall communicate this order to the Speaker of the Legislative Assembly of Goa, Daman and Diu and to the Election Commission, to enable them to act in accordance with this order.
