## OCCUPANCY CERTIFICATE

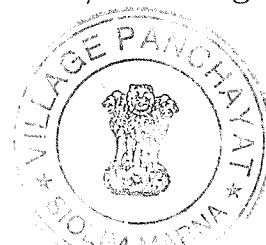

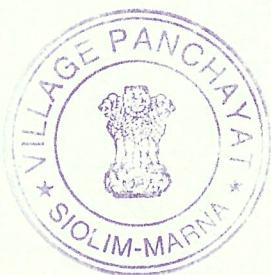
