Goa, General Manager (Operations) of M/s Devashri Nirman Limited Liability Partnership duly authorised by the Promoter of the proposed project named, "LA CALIDA By Devashri" vide Power of Attorney 10.11.2017 executed before the Notary, Smt. Kishori Fugro at Panaji Goa vide Registration No. 1864 dated 14.12.2017 do hereby colemnly declare, undertake and states as under:-
