SANAD SCHEDULE-II

(See Rule 7 of the Goa Land Revenue (Conversion of use of land and non-agricultural Assessment) Rules, 1969).

Whereas an application has been made to the Collector of North Goa (Hereinafter referred to as "the Collector" which expression shall include any officer whom the Collector shall appoint to exercise and perform his powers and duties under this grant) under section 32 of the Goa Land Revenue Code, 1968 (hereinafter referred to as 'the said code which expression shall, where the context so admits include the rules and orders there under by Mr. Agnelo John Nazareth r/o H No. 610, Badem, Assagao, Bardez-Goa, being the occupant of the plot registered under Survey No. 55/4 situated at Assagao Village in Bardez-Taluka (hereinafter referred to as "the applicant, which expression shall, where the context so admits include his/her heirs, executors, administrators and assigns) for the permission to use the plots of land (hereinafter referred to as the "said plot") described in the Appendix I hereto, forming a part under Survey No. 55/4 admeasuring 1248 Sq. mtrs be the same a little more or less for the purpose of Residential with 60 F.A. R.

Now, this is to certify that the permission to use for the said plots is hereby granted, subject to the provisions of the said Code, and rules thereunder, and on the following conditions, namely:-

- 1.<u>Levelling and clearing of the land</u>-The applicant shall be bound to level and clear the land sufficiently to render suitable for the particular non-agricultural purpose for which the permission is granted, to prevent insanitary conditions.
- <u>2.Assessment</u> The applicant shall pay the non-agricultural assessment when fixed by the Collector under the said Code and rules thereunder with effect from the date of this Sanad.
- <u>3.Use</u> The applicant shall not use the said land and building erected or to be erected thereon for any purpose other than <u>Residential</u> without the previous sanction of the Collector.
 - 4.Liability for rates The applicant shall pay all taxes, rates and cesses liable on the said land.
- 5.Penalty clause (a) If the applicant contravenes any of the foregoing conditions, the Collector may, without prejudice to any other penalty to which the applicant may be liable under the provisions of the said Code, continue the said plot in the occupation of the applicant on payment of such fine and assessment as he may direct.
- (b) Notwithstanding anything contained in sub-clause (a) it shall be lawful for the Collector to direct the removal or alteration of any building or structure erected or used contrary to the provisions of this grant within such time as specified in that behalf by the Collector, and on such removal or alteration not being carried out, recover the cost of carrying out the same from the applicants as arrears of land revenue.
- 6. a) If any information furnished by the applicant for obtaining the Sanad is found to be false at a later stage, the Sanad issued shall be liable to be withdrawn without prejudice to the legal action that may be taken against the applicant.
 - b) If any dispute arises with respect to the ownership of the land, than the office of the Additional Collector –III Mapusa shall not be held responsible for the same. And the applicant shall be safely responsible for the same. Further if any dispute arises with respect to the ownership of the land, the Sanad granted shall stand revoked and the construction/development carried out shall be at the cost and risk of the applicant.
 - c) The necessary road widening set-back is to be maintained before any development in the land
 - d) Traditional access passing through the plot, if any, shall be maintained.
 - e) No trees shall be cut except with prior permission of the competent authority.
 - f) The Local bodies should verify the ownership documents at the time of granting construction licence

7. Code provisions applicable –Save as herein provided the grant shall be subject to the provisions of the said Code and rules there under.

- 5. This Sanad is issued for conversion of an area for Residential purpose only. The development/construction in the plot shall be governed as per laws/rules in force.
- 6. Traditional access, passing through the plot, if any shall be maintained.
- Mundkarial rights and Mundkarial area should not be disturbed and should be protected if any.
- 8. The applicant has submitted POA dated 17/02/2022 execute by Adv L.M. Gajinkar at Sr. No. 1794/2022 Dated 17/02/2022.

Village: ASSAGAO


