TECHNICAL CLEARANCE ORDER

Technical Clearance is hereby granted for carrying out for **proposed Construction of Residential Building Block-A & Block-B, Commercial Building Block-C, Swimming Pool and Compound wall (Revised Plan) in Amalgamated plots** by M/s. Mannat Lavicas Residency, as per the enclosed approved plans in the property Zoned as 'Settlement Zone' in Regional Plan for Goa 2021 situated at Village **Morombi-O-Grande**, Tiswadi – Taluka bearing **Survey No. 25/1 & 25/1-A**, with the following conditions:-

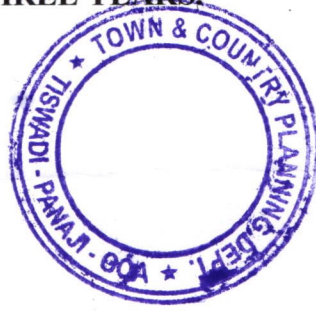
1. Construction shall be strictly as per the approved plans. No change shall be effected in the approved plans/approved built spaces without the prior permission of this Authority.
2. The permission granted shall be revoked, if any information, plans, calculations, documents and any other accompaniments of the application are found incorrect or wrong at any stage after the grant of the permission and the applicant will not be entitled for any compensation.
3. The development permission will not entitle the applicant for making/laying any claim on water and any other connection from the Government of Goa.
4. The Developer/applicant should display a sign board of minimum size 1.00 Mts. X 0.50 Mts. with writing in black color on a white background at the site, as required under the Regulations.
5. The applicant shall obtain Conversion Sanad under the Goa Land Revenue Code, 1968, before the Commencement of any development/construction as per the permission granted by this order.
6. The Septic Tank, soak pit should not be located within a distance of 15.00 meters from any other existing well in the plot area/plan.
7. The commencement and the completion of the work shall be notified to the authority in writing in appropriate forms.
8. Completion Certificate has to be obtained from the Authority before applying for Occupancy Certificate from the licensing authority.
9. Storm water drain should be constructed along the boundary of the effected plot abutting to the road.
10. Adequate Utility space for the dustbin, transformer etc. should be reserved within the plot area.
11. In case of any cutting of sloppy land or filing of low-lying land, beyond permissible limits, prior permission of the Chief Town Planner shall be obtained before the commencement of the works per the provisions of Section 17(A) of the Goa Town & Country Planning Act, 1974.
12. The Ownership and tenancy of land if any of the property shall be verified by the licensing body before the issuing of the license.
13. Panchayat shall ensure the infrastructure requirements such as water supply and garbage before issuing license.

14. The adequate arrangement for collection and disposal of solid waste generated within the plot shall arrange to satisfaction of Village Panchayat.
15. Open parking area should be should be effectively developed.
16. Applicant shall plant one tree for every 100.00m² of area developed, land scaping on open spaces/tree plantation along roads and in developed plots.
17. Adequate avenue greenery should be developed.
18. Stilt floor parking area proposed in the building shall be used for the parking of vehicles only and it shall not be changed for any purpose at any point of time.
19. Gradient of the ramps to the Stilt floor parking area should not be exceed 1:6.
20. Adequate equipments and provisions as per prevailing rules shall be made in the complex so as to take care against any incidents of fire.
21. In case of compound walls, the gates shall open inwards only and if any traditional access passing through the property shall not be blocked.
22. The height of the compound wall strictly maintained as per rules in force.
23. The area under road widening shall not be encroached/ enclosed.
24. Internal 6.00 and 8.00 mtrs roads and parking spaces as shown in the site plan shall be developed at site.
25. This Technical Clearance Order is issued as a partial modification to earlier Technical Clearance Order issued by this office vide letter no. TIS/10128/M-O-G/TCP/2022/1824 dtd 28/9/2023.
26. All the conditions imposed in our earlier Technical Clearance Order issued vide no. TIS/10128/M-O-G/TCP/2022/1824 dtd 28/9/2023 for construction of Residential Building Block A, B, guest house, Block C and swimming pool in Sy. No. 25/1 of Morombi-O-Grande village Tiswadi Taluka by Mr. Antanasio Antonio A.M. Monteiro, shall be strictly adhere to.
27. The Village Panchayat shall take cognizance of any issue in case of any complaints/Court orders before issue of construction license.
28. Applicant should make his own arrangement of water for the swimming pool.
29. Applicant shall dispose the construction debris at his/her own level and/ or the same shall be taken to the designated site as per the disposal plan given by the applicant in the affidavit to be produced to the Village Panchayat.
30. If the proposal involves felling of trees, the project Proponent/Owner shall obtain the prior permission from tree Officer/Forest Department as mandated under Section 8 and 9 of Goa Preservation of Tree Act.
31. Necessary 1 % cess on the total cost of construction project shall be levied by the village Panchayat before issue of completion order by this office.
32. This Technical Clearance Order is issued as per the approval of the Government vide note No. 36/1/TCP/503(Meeting-4)/2024/505 dated 06/02/2024 has approved the grant of Additional FAR of 20 and additional Height of 3.00mtrs.
- 33. Applicant has to provide Common Telecom Infrastructure (CTI) as per order no: 21/1/TCP/MISC/2023/720 dtd 27/04/2023 issued by Chief Town Planner (Adm).**
34. This Technical Clearance Order is issued with the approval of the Government, vide note no. TIS/10128/M-O-G/TCP/2024/77 dtd 01/07/2023.

NOTE:

- a) This Technical Clearance Order is issued based on the order issued by the Secretary (TCP) vide no. **29/8/TCP/2018(Pt.File)/1672** dated **13/08/2018** pertaining to guide line for processing various application.
- b) An engineer who designs the RCC structure, of the project proponent is liable for structural designs and stability of the project, structural liability certificate issued by an Engineer **Mr. Rajesh m. Raikar** dtd. **01/03/2024** TCP Reg. No. **TCP/SE/0009/15**.
- c) This Order is issued with reference to the application dated **04/03/2024** from **M/s. Mannat Lavicas Residency**.
- d) Applicant had paid infrastructure tax of Rs. 4,76,688/- (Rupees Four lakh Seventy Six Thousand Six Hundred Eighty Eight Only) vide challan no. 202400648376 dated 02/09/2024. Earlier applicant had paid infrastructure tax of Rs. 3,07,416/- (Rupees Three Lakh Seven Thousand Four Hundred and Sixteen Only) vide Challan No. 202300694512 dtd 22/09/2023.
