3. We estimate Total Estimated Cost of completion of the building(s) of the aforesaid project under reference as **Rs.13,37,81,975/-** (Total of Table A& B). The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate / completion certificate for the building from the **Town and Country planning department, Mapusa Bardez Goa** being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.
