- 4) The applicant should make independent provision for garbage disposal within the plot area by constructing compost pit and dispose the same properly in scientific manner.
- 5) The applicant should pay 1% of labour cess to this office within a period of one month on estimated cost of the building if not paid by the applicant during issue of construction licence.
