**Provisional N.O.C. from sanitation point of view for Proposed Construction of Residential Villas A, B, C, Swimming Pool, Wells and Compound wall (Revised Plan).**

With reference to your letter No. Nil dated 10/11/2020, it is to inform you that this Primary Health Centre, Siolim has **NO OBJECTION FROM SANITARY POINT OF VIEW** to issue NOC for proposed construction of Residential Vilas A, B, C, Swimming Pool, Wells and Compound Wall (Revised Plan) as per TCP order no. TPB/2821/ASSG/TCP-2020/3943 dated 02/11/2020 on property bearing Survey No. 186/5, plot No. nil at Assagao, Bardez, Goa subject to the following conditions:

1. The construction shall be carried out as per the plan submitted.
2. The septic tank/soak pit of toilet shall be **15** meters away from any water source.
3. The capacity of two septic tanks/soak pits should correspond with dimensions shown in the chart submitted to this office for **10 & 100** persons respectively.
4. Proper cleanliness should be maintained in and around the construction site.
5. No health hazard or any other environmental pollution shall be created in the surrounding area.
6. The owner/contractor shall co-operate with the Health and Pollution Control Authorities whenever they visit to the site for sanitary inspection.
7. If any complaints come from the sanitary point the N.O.C. will be revoked.
8. As per section 75 A of Goa Public Health Act all labourers should possess health cards and should renew them once in three months. No labourer shall be engaged by the owner/contractor without a valid health card. Whoever contravenes the above provisions of the Health Act shall be punishable at the site and should be produced to the Health Staff on demand.
9. Health cards should be available at the site and should be produced to the Health Staff on demand.
10. All Sanitary facilities (Toilet, Soak pit for proper disposal of waste water, Mosquito nets, etc.) are provided to the labourers at the site, before starting the construction.
11. Adequate anti-larval measures at the construction site in consultation with the undersigned should be taken.
12. The owner/contractor should display on the signboard fixed at the site, site details, and name of the Proprietor/Builder/Contractor, the date and NOC obtained from Health Authority.
13. The N.O.C. is liable to be withdrawn if the conditions stipulated above are not complied with.
14. This office is not responsible for any court Litigation regarding the ownership and area of the property.
