PARESH ATMARAM SINAI SAWARDEKAR, son of Mr. Atmaram Sawardekar, 42 years of age, Indian National, promoter of the project mentioned herein below, do hereby solemnly declare, undertake and state as under;

1) That TRIDENTIA DEVELOPERS, has a legal title report to land on which development of ongoing project under name and style as 'GALERIA RESIDENCES' is being carried out and a legally valid authentication of title of such land along with an authenticated copy of Agreement for Sale signed between the Land owner and the promoter 'Tridentia Developers' for development of the ongoing project 'GALERIA RESIDENCES' is enclosed herewith.

That the project Land is free from all encumbrances.

- 3) That the time period within which the project shall be completed by the promoter from the date of registration of the project is 31/12/2025.
- 4) (i) That seventy percent of amount to be realised hereafter by us for the aforesaid real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a Scheduled bank to cover the cost of construction and the land cost and shall be used for that purpose in accordance with rules framed by State Government.

OR

- (ii) That entire amounts to be realized hereinafter by the promoter for the real estate projects from the allottees, from time to time, shall be deposited in a separate account to be maintained in a Schedule bank to cover the cost of construction and the land cost and shall be used for that purpose, since the estimated receivable of the project is less than the estimated cost of completion of the project.
- 5) That amounts from separate account shall be withdrawn in accordance with section 4(2) (1) (D) read with rule 5 of the Goa Real Estate Rules, 2017.

- 6) That I shall get accounts audited within six months after end of every financial year by a Chartered Accountant in practice, and shall produce a statement of accounts duly certified and signed by such Chartered Accountant, and it shall be verified during audit that the amounts collected for a particular project have been utilized for the project and withdrawal has been in compliance with proportion of percentage of completion of the project.
- 7) That I/the Promoter shall take all the pending approvals on time, from competent authorities.

8) That I shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of the said Rules, within seven days of occurring of the said changes.

That I shall furnish such other documents as have been prescribed by rules and regulations made under the Act.

0) That I shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
