amounts collected till 31.03.2022 is Rs.55,32,85,804/-.

iii) Amount withdrawn during the year 2021-22for this project is Rs 9,19,50,000/- and

total amount withdrawn till 31.03.2022is Rs.17,54,32,385/-.

4. We certify that the Manglam Build Developers Limited has utilized the amounts collected

forManglam Casa Amora part 1 project only for that project and the withdrawal from the

same bank account of the said project has been in accordance with the proportion to the

percentage of completion of the project. However during verification following points were

observed:-
