- (b) For on-going projection date of commencement of the Act.


- (i) That seventy per cent of amount to be realised hereafter by me / promoter for the real estate project from allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover cost of construction and land cost and shall be used only for that purpose accordance with Rules framed by State Government.

OR

- (ii) That entire amount to be realised hereafter by me / promoter for real estate project from allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover cost of construction and land cost and shall be used only for that purpose, since estimated receivable of the project is less than estimated cost of completion of the project accordance with Rules framed by State Government.

5. That the amounts from separate account shall be withdrawn in accordance with Rule 4(2)(I)(D) read with the Rule 5 of the Goa Real Estate (Regulation and Declaration) (Registration of Real Estate Project, Registration of Real Estate Agents, Rates of Interest and Disclosure on Website) Rule 2017.
6. That I / promoter shall get accounts audited within six months after end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during audit that amounts collected for a particular project have been utilised for the project and withdrawal has been in compliance with proportion to percentage of completion of the project.
7. That I / promoter shall take all approvals on time from competent authorities.
8. That I / promoter have / has furnished such other documents as have been prescribed by rules and regulations made under the Act.

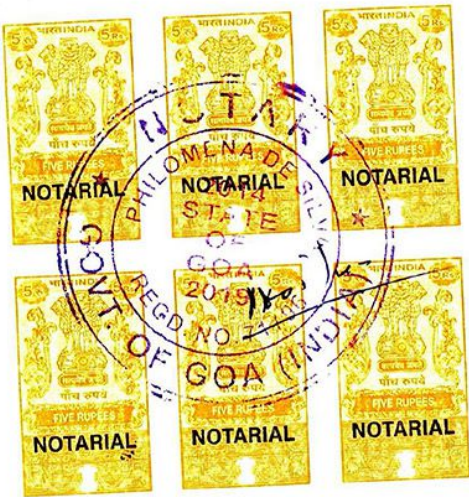
