JUDGEMENT

This order shall dispose the application of the applicant dated 16th July,2015 requesting therein to amalgamate the properties surveyed under Survey Nos./ Sub-division No. 240/4 and 240/6 situated at Socorro village of Bardez Taluka, on its name as occupant.

The brief fact of the case is that the above applicants are the lawful owner and are in possession of the properties surveyed under Survey Nos. / Sub- division No.240/4 and 240/6 situated at Socorro village of Bardez Taluka and wants to amalgamate the same on its name as occupant.

Due intimate under rule 11 of Goa Daman & Diu of Land Revenue Rules 1969 (Revenue Survey & Sub Division of Survey Numbers) were issued to remain present for enquiry. Accordingly the applicant remained present. He produces in

record Deed of Sale dated 26/3/93, 26/10/93 and 15/08/2013, registered in Sub-Registrar Office Bardez, Form No. I & XIV and also stated that they have peaceful possession on ground.

After the preliminary enquiry the case was fixed for site Inspection. The Field Surveyor who inspected the property and submitted plan along with site Inspection report to this court. The said report and plan is taken on record as exhibit.

Thereafter the matter was fixed for evidence of the applicants. The applicants who was present produced on record Statement on oath in evidence. In the Sworn Statement on oath the applicant states that they are in peaceful possession of the said properties and no other person has got any right over the properties.

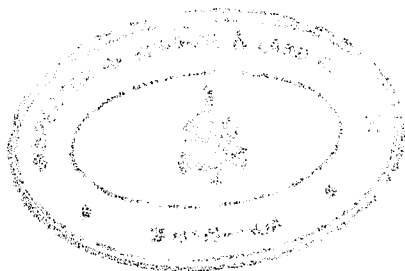
I have gone through the applications of the Statement on oath in evidence and other documents on record and satisfied that the applicants has proved his possession of the above properties. In view of the above and in exercise of the power vested on me, I pass the following Order.


ORDER

The properties surveyed under Survey Nos./Sub-division Nos. 240/4 and 240/6 situated at Socorro village of Bardez Taluka are amalgamated as Survey No. 240/4 for an area of 3100 sq.mts. The Survey Nos./Sub-division No. 240/6 is cancelled, the Newly amalgamated Survey No./Sub-division Nos. 240/4 be recorded in the names of (1) Shri Gokuldas Tukaram Verdekar (2) Smt. Ramchandra Ganpat Rao,
