As regards to the structural stability and safety to all, concerned owner and his Engineer shall be solly responsible and the Town Planner and his all officials are indemnified and kept indemnified forever against any civil and or criminal liabilities and for any kind of liability, whatsoever in the event of any untoward incident or structural failure/collapse. This will hold good (and will be valid) even in case some of any prescribed documents inadvertently are not on record (not received by the Town & Country Planning Office or wrongly submitted by Applicant/Applicants representative.

6. As regards to validity of conversion Sanad, renewal of license, the same shall be confirmed by the Municipality/Panchayat before issuing Occupancy Certificate.

7. As regard to complaints, pertaining to encroachments, judicial Order/directives other legal issues, the same may be verified and confirmed by the concern Municipality/Panchayat before issuing Occupancy Certificate.
