Completion is hereby certified for **Construction of residential Villa-G & H & Swimming pool** which is constructed as per the Technical Clearance granted by this Department vide Order no. TPB/1581/ASSG/TCP-2025/765 dt. 18/02/2022 & **Construction of residential Villa-F & Swimming pool (Revised Plan)** which is constructed as per the Technical Clearance granted by this Department vide Order no. TPB/1581/ASSG/TCP-2025/5904 dt. 27/06/2025 at **Sy. No. 197/1 of village Assagao Taluka Bardez** subject to the following conditions.
