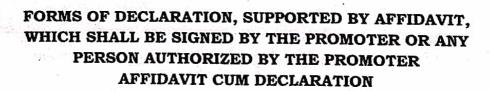

Shubhada Pradip Verekar vide their authorization Power of Attorney bearing Regn.No. PON-POA Register-8-2022 dated 11/05/2022; I Shri. Narayanrao R. Desai son of Ramchandra Desai age 40 yrs, Indian National, do hereby solemnly declare, undertake and state as under:

(1) That I / promoter have/has legal title report to the land on which the development of the project is proposed

OR

have/has a legal title Report to the land on which the development of the proposed project is to be carried out

## AND

(2) That the project land is free from all encumbrances.

## OR

- (3) That the time period within which the project shall be completely by me/promoter from the date of registration of project; is 31/12/2026.
- (4) For ongoing project on the date of commencement of the Rules----
- (i)That seventy per cent of the amounts to be realized hereinafter by me/ promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a

(5)That the amounts from the separate account shall be withdrawn in accordance with section 4(2)(I)(D) read with rule 5 of the Goa Real Estate (Regulation and Development) (Registration of Real Estate Projects, Registration of Real Estate Agents, Rates of Interest and Disclosures on Website) Rules, 2017.

(6)That I/the promoter shall get the accounts audited within six months after the end of every financial year by practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

(7) That I/the promoter shall take all the pending approvals on time, from the competent authorities.

(8)That I/the promoter shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-



section (2) of section 4 of the Act and under rule 3 of the said Rules, within seven days of the said changes occurring.

(9)That I/the promoter have/has furnished such other documents as have been prescribed by the rules and regulations made under the Act.

(10)That I/the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
