#### REVISED CONSTRUCTION LICENSE

Mr. CLIFF CYRIL SEQUEIRA & MR. SHABBIR A. KHOKAWALA ALIAS SHABBY A. KHOKAWALA of Tivim, Bardez, Goa, is hereby granted permission for Construction of Residential Bulding and Swimming Pool (Revised Plan) in survey no. 150/2 at Tivim, Bardez, Goa, in terms of resolution no. XIII/15, taken in the Panchayat Meeting dated 07/01/2023.

- The applicant shall strictly comply all the conditions imposed in the Development Permission/Order NoTPB/3850/TIV/TCP-22/6992, dated 07/11/2022, Issued by the Technical Clearance Order issued by the Town and Country Planning Department Mapusa.
- 2. The applicant shall notify the Panchayat for giving the alignment of the building.
- The construction should maintain the minimum prescribed horizontal and vertical clearances from any overhead electrical line passing adjacent to the construction.
  - All RCC/Structural works shall be designed and supervised by the Engineer who has signed the structural Liability Certificate submitted to the Panchayat.
  - NO material for construction or earth from excavation or any other construction material Shall be stacked on the Public roads.
  - 6. The Building should not be occupied unless the occupancy certificate is obtained from the Panchayat.
  - 7. The construction license shall be revoked if the construction work is not executed as per the approved plans and the statements therein and whenever there is any false statement or misrepresentation of any material passed, approved or shown in the application on which the permit was based.
  - 8. The applicant should construct a separate soak pit in order to derivate in the sullage water.
  - 9. Any soak pit should be constructed at a minimum distance of 15 meteres away from any well.
  - 10. The ventilation pipe of the septic tank should be provided with a mosquito net.
  - 11. The Applicant should connect the pipelines from their latrines/WC's to the sewerage line at their own cost, when the sewerage line is commissioned.
  - 12. The applicant should fix a board at a prominent place whenever the construction is started, indicating the number, the date and the authority for which the license for development work has been granted.
  - 13.All the building material and other rubbish should should be cleared from the construction site before applying for the occupancy certificate.
  - 14. Water storage tanks shall be provided with mosquito proof lids and overflow pipes. The tanks should be provided with access ladders wherever necessary.

- 15. The drains surrounding the plot is any should be constructed with PCC and should be covered with removable RCC slabs of sufficient thickness.
- 16. The applicant should plaster and paint the building internally as well as externally before applying for Occupancy Certificate. Exposed brick/laterite/concrete/stone/ashlars masonary finish to building will also be permitted.
- 17. The applicant should provide a dusbtin at a convenient place accessible for the Municipal/Panchayat vehicle for collection of garbage.
- 18. Road widening area shall be asphalted to the existing road level before applying for occupancy certificate.
- 19.Garages and Parking areas shown in the approved plan shall be strictly used for parking purposes only and should be easily accessible to vehicles. No commercial activities shall be allowed in these areas.
- 20. Access upto the entrance of the building is to be paved and is provided with drainage facilities.
- 21. Space for parking of vehicles is clearly demarcated on the ground.
- 22. Fire Escape staircase, if applicable shall be constructed as indicated in the approved plans.
- 23.All internal courtyards should be provided with drainage outlet.
- 24. The applicant should maintain all existing natural drains in the plot and should not block them at any stage.
- 25. No soak pit or other structures should come in the road widening area.
- 26. The plot boundary should be cordoned off by continuous sheet fencing either of wood or metal during the construction period.
- 27. The adequate arrangement for collection and disposal of solid waste generated within the complex shall arranged to satisfaction of this panchayat.
- 28. Adequate avenue greenery should be developed.
- 29. The said building should be used for residential purpose only as per the Techical Clearance Order. Contd. On pg 3....

- 30. Storm water drain should be constructed along the boundary of the effected plot abutting To the road.
- 31. The applicant should provide a dusbtin at a convenient place accessible for the Panchayat vehicle For collection of garbage.
- 32. Applicant shall dispose the construction debris at his/her own level and/or the same shall be taken to the designated site as per the disposal plan given by the Applicant in the Affidavit at his own expenses.
- 33. Applicant shall produce the certificate issued by the concerned PWD officials of designated sites as mentioned in the said Notification dated 07-03-2018.
- 34. Failing to comply clause (a) and (b) the penalty shall be imposed to the Applicant at the rate of 0.5% on the total cost of the project and also the construction license issue to the Applicant shall be withdrawn/cancelled.
- 35. The area under road widening shall not be encroached/enclosed.
- 36. Applicant shall plant one tree for every 100.00m2 of area developed, land scaping on open spaces/tree plantation along roads and in developed plots.
- 37. Segregation of plastic waste into dry & wet should be carried out at the site. Dry waste should be handed over to the panchayat & wet waste should be Dumped in your backyard for time being.
- 38. Applicant shall make his own arrangement of water requirements for swimming pool.
- 39. This technical Clearance order is issued relying on survey plan submitted to this office. In case of any boundary/encroachment if any shall be resolved by the applicant with clear demarcation of boundary stones from Directoratre of settlement and land records. This office shall not be held responsible at any point of Time, as this Technical Clearance orde issued is only from planning point of view.

- 40. Before applying for Occupancy, the owner/Power of Attorney Holder/Builder/etc., should make provisions for water harvesting in their plot/property.
- 41. The owner should hand over open space, roads ect.& the costs for transferring the title in the name of panchayat should be borne by the owner/builder himself.
- 42.. Occupancy certificate should be taken from this office after completion of work of Construction of Residential building and Swimming Pool (Revised Plan).
