1) Internal pipeline shall be 90mm /63mm/50mm OD PVC (ISI mark) of a

2) Sluice valve of PN 1.00 rating ISI approved brand shall be installed at locations mentioned in the layout plan.

3) 25mm dia Air Valves of ISI approved brand shall be installed at location

4) Pipeline shall be laid 1.00 meter below the ground level. Trenches shall be cleared only after the inspection.

5) Sand shall be provided up to minimum 30 cm above the pipeline laid where

6) The chamber shall be of brick masonry with necessary cover and CI surface box with inside dimensions as below 60x60x75 cm

7) The pipeline shall be hydraulically tested for 6kg/cm2 pressure for 24 hours which shall be witnessed by departmental officers.
