DEED OF RELEASE

THIS DEED OF RELEASE made on this 4th day of February, 1970, at Margão, BETWEEN Smt. 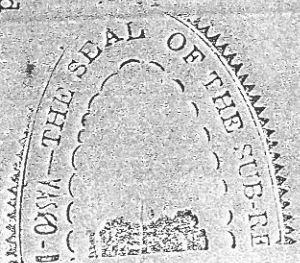
(hereinafter called the "RELEASEE") of the 2nd Part, and

Cundaim, (hereinafter called "POTENTIAL HEIRS") of the

WHEREAS the RELEASEE together with her late husband  
Shri Narcinva Damodar Naik made a gift to the RELEASEE  
her son, of certain immovable properties specified in the  
deed of gift dated 1st April 1963<sup>and described in schedule annexed</sup> and executed before the  
Notary Public of Salcete at, Margaao, Santa Rita Vaz.

AND WHEREAS the said gift was made with reserve of  
usufruct of the said properties for life of the donors.

AND WHEREAS the donor, the said Narcinva Damodar  
Naik died at Bombay on 9th April 1966 and therefore the  
said usufruct now vests in RELEASEE.

AND WHEREAS the RELEASEE and her three sons and  
daughter have this day entered into an Agreement of Family  
settlement and as part of such family settlement the

That in consideration of the premises and as part of said family settlement, the RELEASOR does hereby renounce and relinquish her usufruct to the immovable properties gifted to the RELEASEE by the said deed of gift dated 1st April 1963.

AND that in consequence as the result of renouncement or relinquishment of the said usufruct, the RELEASEE has become full owner of the said properties.

That the third party, as sons and daughter of the RELEASOR and her POTENTIAL HEIRS, in pursuance of the aforementioned family settlement, hereby acknowledge and agree and give their consent to the above RELEASE made by the first party in favour of the second party.

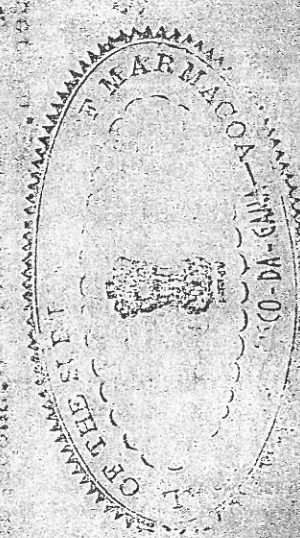
