### OCCUPANCY CERTIFICATE

#### Subject to the following conditions:-

1. All conditions stipulated in the Completion Order/Technical Clearance Order from PDA/TCP should be strictly adhered to.
2. This Certificate Shall be treated as NOC for obtaining Water and Electricity connection.
3. The Applicant should make independent provision for Garbage disposal within the Plot Area by constructing compost pit and dispose the same properly in scientific manner.
4. No construction should be carried out after obtaining Occupancy Certificate.
5. The yearly House Tax assess as follows along with the House Number.
6. The Premises should not be used for purpose other than mentioned in this certificate except with due permission of this Village Panchayat.
7. The Owner/Occupier should maintain the open space and footpath clean.
8. The footpath should be properly maintained and kept free from obstruction or encroachment.
9. Drain water and septic tank water should be given proper outlet for disposal and hygienic condition surrounding the building should be maintained by the occupier at his own cost.
