No. 18/504, Rustomjee Evershine Global City, Virar West, Virar, Palghar, Maharashtra 401303 by resolution dated 7th August 2023.

≠ do hereby solemnly declare, undertake and state as under.

- (1) That Impactum Lands Private Limited has a legal title to the plot bearing Survey 178/1-A-Q-3 of Sancoale Village, Mormugao Taluka, Goa on which the development of the project namely "Gulf of Goa" is proposed.
