Cipriano Xavier de Souza expired on 3rd October 1958 without leaving ascendants or descendants in status of bachelor and without executing a will leaving behind as his sole and universal heir his sister Albertina Efigenia Balduina Celestina Conceicao de Souza alias Albertina Efigenia Balduina de Souza.
