- That I/the promoter shall get the accounts audited within six months after the end of (6)every financial year by a practicing Chartered Accountant and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- That I/the promoter shall take all the pending approvals on time, from the competent (7)authorities.
- That I/the promoter shall inform the Authority regarding all the changes that have (8)occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of the said Rules, within seven days of the said changes occurring.
- That I/the promoter have/has furnished such other documents as have been prescribed by (9)the rules and regulations made under the Act.
- That I/the promoter shall not discriminate against any allottee at the time of allotment of any (10)Apartment, plot or building, as the case may be.
