3. BRIEF HISTORY OF THE PROPERTY/IES AND HOW THE OWNER HAS DERIVED THE TITLE:

There Exists a Property admeasuring an area of 2808:00 square metres known as "BAMNALEM" situated at Mormugao and which is surveyed under Chalta No.08 of P.T.Sheet No.70 City of Vasco da Gama, and enrolled in the Taluka Revenue Office under Matriz No.350 herein after referred to as the "SAID PROPERTY".
- 2. The said property originally was owned and possessed by Mr. Rafael Araujo alias Rafael Luis Gonzaga de Menino Jesus Araujo.
- Mascarenhas Araujo under the regime of Communion of property. The said Mrs. Eutemia Mascarenhas Araujo expired on 23.12.1973 & Mr. Rafael Araujo expired on 28.12.1976 respectively, leaving behind them their five children's namely (1) Mr. Caetano Jose do Patrocinio Mascarenhas Araujo alias Caetano Jose Mascarenhas Araujo, (2) Mr. Edwin do Patrocinio Mascarenhas Araujo alias Araujo, (3) Mr. Fausto do

Patrocinio Mascarenhas Araujo alias Fausto Mascarenhas Araujo, (4) Mrs. Yvette do Patrocinio Mascarenhas Araujo alias Mrs. Yvette Filomena Araujo Cruz and (5) Mr. Oscar do Patrocinio Mascarenhas Araujo alias Oscar Mascarenhas Araujo as their successors.

- 4. The name of 4(four) children's namely (1) Mr. Fausto Mascarenhas Araujo, (2) Mr. Edwin Mascarenhas Araujo, (3) Mr. Oscar Mascarenhas Araujo, (4) Mr. Caetano Jose Mascarenhas Araujo (excluding the name of Mrs. Yvette do Patrocinio Mascarenhas Araujo) is been entered in the Records of Rights i.e. FORM D of the City Survey of Vasco da Gama as per the Order dated 08.08.1983 passed by the Enquiry Officer, City Survey of Mormugao, at Vasco da Gama.
- 5. That Inventory Proceedings No.96/2000/M was instituted in the Court of Adhoc Additional Senior Civil Judge at Margao upon the death of Mr. Rafael Araujo alias Rafael Luis Gonzaga de Menino Jesus Araujo and Mrs. Eutemia Mascarenhas Araujo by their son Mr. Edwin do Patrocinio Mascarenhas Araujo, wherein the said property was mentioned in the additional list of assets at item No.6 filed in the Port. Civil Misc. Application No.133 of 2013 in Inventory Proceedings No.96/2000/M and by consent terms dated 31.10.2013 the assets were allotted in equal shares to all the parties as mentioned below:
 - i. 1/5th to Mr. Caetano Jose do Patrocinio Mascarenhas
 Araujo.

ii. 1/5th to Mr. Oscar do Patrocinio Mascarenhas Araujo.

- iii. 1/5th to Mr. Edwin do Patrocinio Mascarenhas Araujo.
- iv. 1/5th to Mr. Fausto do Patrocinio Mascarenhas Araujo.
- v. 1/5th to Mrs. Yvette do Patrocinio Mascarenhas Araujo.
- 6. Mr. Oscar do Patrocinio Mascarenhas Araujo died on 24.01.2017 and consequent to his death, by a Deed of Relinquishment drawn on 15.09.2017 recorded at Folio 40V to 41 of Deed Book No.1643 dated 22.09.2017 before the Office of the Civil Registrar cum Sub-Registrar, Special Jose do Patrocinio Notary, Salcete Mr. Caetano Mascarenhas Araujo, Sylvia Noronha e Araujo, Edwin do Patrocinio Mascarenhas Araujo, Prithi Maria De Sousa e Araujo, Yvette do Patrocinio Mascarenhas Araujo, Julio Caesar Cotta Cruz alias Julio Cesar Barreto Cruz relinquished their rights in the estate of their brother/brother in law late Mr. Oscar do Patrocinio Mascarenhas Araujo in favour of remaining co-heir namely Mr. Fausto do Patrocinio Mascarenhas Araujo.
- 7. From the above, it can be seen that the said property known as "Bamnalem" admeasuring 2808:00 square metres, bearing Chalta No. 08 of P. T. Sheet No. 70 was been jointly owned by the following heirs/persons in respective ratio as follow:
 - I. 1/5th to Mr. Caetano Jose do Patrocinio Mascarenhas Araujo.

- II. **1/5**th to Mr. Edwin do Patrocinio Mascarenhas Araujo.
- III. **2/5th** to Mr. Fausto do Patrocinio Mascarenhas Araujo.
- IV. 1/5th to Mrs. Yvette do Patrocinio Mascarenhas Araujo.
- The aforesaid parties/Co-owners namely Mr. Caetano Jose 8. do Patrocinio Mascarenhas Araujo, Sylvia Noronha e Araujo, Edwin do Patrocinio Mascarenhas Araujo, Prithi Maria De Sousa e Araujo, Yvette do Patrocinio Mascarenhas Araujo, Julio Caesar Cotta Cruz alias Julio Cesar Barreto Cruz and Mr. Fausto do Patrocinio Mascarenhas Araujo sold the Said Property admeasuring an area of 2808:00 square metres known as "BAMNALEM" situated at Mormugao and which is surveyed under Chalta No.08 of P.T.Sheet No.70 City of Vasco da Gama, and enrolled in the Taluka Revenue Office under Matriz No.350 unto and in favour of M/s. Resources Earth, a Partnership Firm consisting of Partners Mr. Avez Azim Shaikh, Mr. Ashvek Hima Bhoi and Mrs. Sadhana Ashvek Bhoi.
- 9. Thus M/s. Resources Earth mutated the name in the records of rights i.e (Form D) in respect of the said property surveyed under Chalta No.08 of P.T. Sheet No.70 of City Survey of Vasco da Gama.
- **10.** Hence from dated 18.12.2018 M/s Resources Earth, a Partnership firm is the lawful Owner in possession of the Said Property.
