- (7) That the Company shall take all the pending approvals on time, from the competent authorities.

- (8) That the Company shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of the said Rules, within seven days of the said changes occurring.
- (9) That the Company have furnished such other documents as have been prescribed by the rules and regulations made under the Act.

(10)That the Company shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
