I, **Engr. 1. Following technical professionals are appointed by '**M/S. Raj Housing Development Pvt. Ltd.**':-
 - (i) Mr. Sidharth Naik (ULYSIS) as Architect;
 - (ii) Mr. Abhay U Kunkolienkar as Structural Consultant;
 - (iii) M/S Aqua Utility Designs & Management Pvt Ltd as MEP Consultant;
 - (iv) Mr. Ambrish Goavekar as Quantity Supervisor;
2. We have estimated the cost of the completion to obtain Occupation Certificate/Completion Certificate, of the Civil, MEP and Allied Works, of the '**Block-A, Block-B & Block-C of Phase - I**' of the Project '**RAJ ENCLAVE**'. Our estimated cost calculations are based on the Drawings/plans made available to us for the project under reference by the Developer and Consultants and the Schedule of items and quantity for the entire work as calculated by Mr. Ambrish Goavekar quantity Surveyor appointed by **M/S. Raj Housing Development Pvt. Ltd.**, and the assumption of the cost of material, labour and other inputs made by developer, and the site inspection carried out by us.
3. We estimate Total Estimated Cost of completion of the '**Block-A, Block-B & Block-C of Phase - I**' of the aforesaid project under reference as Rs. **31,11,23,807.00** (Total of Table A and B). The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate/ completion certificate for the '**Block-A, Block-B**

& Block-C of Phase - I ' from the Nouth Goa Planning and Development Authority being the Planning Authority and Municipal Council of Mapusa under whose jurisdiction the aforesaid project is being implemented.

4. The Estimated Cost Incurred till date is calculated at Rs. **5,31,96,562.00** (Total of Table A and B). The amount of Estimated Cost Incurred is calculated on the base of amount of Total Estimated Cost.
5. The Balance cost of Completion of the Civil, MEP and Allied works of the 'Block-A, Block-B & Block-C of Phase - I ' of the subject project to obtain Occupation Certificate/ Completion Certificate from NGPDA (planning Authority) and Municipal Council of Mapusa is estimated at Rs. **25,79,27,245.00** (Total of Table A and B).


