(2) This certificate shall be treated as NOC for obtaining water and power connection.

(3)The applicant should make independent provision for Garbage disposal within the plot Area by constructing Compost Pit and dispose the same properly in scientific manner.

(4) The Premises should not be used for purpose other than mentioned in this certificate except with due permission of this Village Panchayat.
