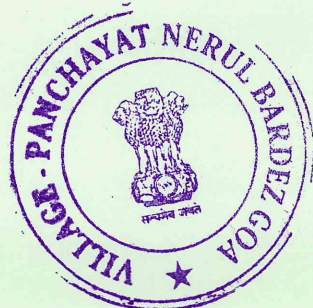
Subject to the following Conditions:-


